

The striking hammer indicates that the highest bid has been accepted and that a contract for sale between the seller and the buyer has been concluded. CONDITIONS OF SALE

These Conditions of Sale and the Important Notices and Explanation of Catalogue Practice contain all the terms on which Paidegao International Auctioneer Limited ("Paidegao") and the seller contract with the buyer. They may be amended by posted notices or oral announcement made during the sale. By bidding at auction the bidder agrees to be bound by these terms.

1. PAIDEGAO AS AGENT

The role of Paidegao is the agent for the seller, except as otherwise stated. The contract for sale of the property is made between the seller and the buyer.

2. BEFORE THE SALE

(a) Examination of property

Before the commencement of the auction, prospective buyers ought to examine any property they are interested in personally. Condition reports are usually available on demand. Neither Paidegao nor the seller provides any guarantee concerning the nature of property, apart from the Limited Warranty (Please refer to paragraph 6 below). Otherwise, the property is sold "as is".

(b) Catalogue and other descriptions

All statements made orally or in writing by us, in the catalogue entry for the property, the condition report or elsewhere, are statements of opinion and are not to be deemed as statements of fact. Such statements do not make up a representation, warranty or assumption of liability by us of any kind. References in the catalogue entry or the condition report to damage or restoration are only for guidance and should be evaluated by personal inspection by the bidder or a knowledgeable representative. The absence of such a reference does not indicate that an item is free from defects or restoration. A reference to particular defects does not imply the absence of any others. Estimates of the selling price do not suggest the actual selling price or the value for any other purpose. Neither Paidegao nor the seller assumes responsibility in any way for errors and omissions in the catalogue or any supplemental material (except as set forth in paragraph 6 below).

(c) Buyer's responsibility

Without any representation or warranty of any kind by Paidegao or the seller, all property is sold "as is" (except as stated in the Limited Warranty in paragraph 6 below). It is buyers' responsibility to satisfy themselves regarding the condition of the property and the matters referred to in the catalogue entry.

3. AT THE SALE

(a) Refusal of admission

At its complete discretion, Paidegao has the right to refuse admission to the premises or participation in any auction and to reject any bid.

(b) Registration before bidding

Before bidding, a prospective buyer must complete and sign a form of registration and provide identification. The production of bank or other financial references may be required.

(c) Bidding as principal

By making a bid, a bidder accepts personal liability to pay the purchase price, including the buyer's premium and all applicable taxes, plus all other applicable charges. Bidding

as agent on behalf of an identified third party has to be explicitly agreed in writing with Paidegao before the sale commences. If this is the case, Paidegao will only look to the principal for payment.

(d) Absentee bids

For the convenience of clients who are not present at the auction in person, by an agent or by phone, written bids may be delivered to Paidegao in advance of the sale. Paidegao will put reasonable efforts in carrying out such bids. (e) Telephone bids

Paidegao will use reasonable efforts to contact prospective buyers but we are not liable for the failure to do so or for errors and omissions in connection with telephone bidding.

(f) Currency converter

A currency converter may be operated at some auctions. Errors may occur in the operation of the currency converter. Bidders are advised to follow the actual bidding in the saleroom. We do not accept liability to bidders who follow the currency converter rather than the actual bidding in the saleroom.

(g) Video or digital images

Video or digital screen may be used at some auctions. Errors may occur in the operation and the quality of the image may not be satisfying. We do not accept liability for such errors.

Paidegao reserves the right to videotape and record proceedings at any auctions. Any personal information obtained will be held in confidence by Paidegao. For the purpose of customer analysis, such information may be used or shared with our affiliates and marketing partners. Any buyer who does not wish to be videotaped may arrange to make a telephone bid. For details, please refer to paragraph 3(e) above.

(h) Reserves

Some lots are offered subject to a reserve. The reserve is the confidential minimum price below which the lot will not be sold. The reserve will not exceed the low estimate printed in the catalogue. The auctioneer may open the bidding on any lot below the reserve by placing a bid on behalf of the seller. He or she may continue to bid on behalf of the seller up to the amount of the reserve. Such bids may be consecutive or be placed in response to other bidders.

Regarding the lots that are offered without reserve, in his or her discretion, the auctioneer will generally open the bidding at 50% of the low pre-sale estimate for the lot, unless there are already competing bids. If a bid at that level is absent, in his or her discretion, the auctioneer will proceed backwards until a bid is recognized, and then continue up from that amount. In case a higher bid is absent, absentee bid will be executed at about 50% of the

low pre-sale estimate, or at the amount of the bid if it is less than 50% of the low pre-sale estimate.

(i) Auctioneer's discretion

Risk and responsibility for the lot, but not its title, passes to the successful bidder at the expiration of seventh working days from the date of the sale or on collection by the successful bidder if earlier.

4. AFTER THE SALE

(a) Buyer's premium

The successful bidder agrees to pay to Paidegao the buyer's premium plus any applicable tax and charges, in addition to the hammer price. The buyer's premium is 15% of the hammer price of each lot.

Payment and passing of title

The successful bidder must provide us immediately after the sale with his or her name and permanent address and, upon request, details of the bank for payment. The successful bidder must pay the full amount due (including the hammer price, buyer's premium and any applicable taxes) by 4:30pm on or before the seventh working days following the sale. This applies even if the successful bidder plans to export the lot and an export license is, or may be, required. The successful bidder will only acquire title to the lot when all amounts due from the successful bidder to Paidegao have been received in good cleared funds, even if Paidegao has released the lot to the successful bidder.

(b) Collection of purchases

Paidegao has the right to retain items sold until all amounts due to Paidegao has been received in full in good cleared funds, or until the buyer has satisfied other terms required by, in its sole discretion, Paidegao. The successful bidder is then entitled to collect purchased lots within thirty days from the date of the sale, unless otherwise agreed between Paidegao and the successful bidder. If the lot is not collected within this period, Paidegao shall arrange storage at the successful bidder's expense at HK\$50 per lot per day.

(c) Packing, handling and shipping

Paidegao shall use reasonable efforts to take care when handling, packing and shipping a purchased lot. However, we assume no responsibility for the acts or omissions of third parties whom we might retain for these purposes. (d) Export/ Import license

Unless agreed by Paidegao in writing, the successful bidder is under the obligation to make payments within seven days. Such obligation and Paidegao's right to charge interest or storage charges on late payment are not affected by the successful bidder's plan to apply for an export license. In case the successful bidder requests Paidegao to apply for an export license on his or her behalf, Paidegao has the right to make a charge for this service. (e) Remedies for non payment

If the successful bidder fails to make payment in full in good cleared funds within the time required by paragraph 4(a) above, in its own discretion, in addition to asserting any other rights or remedies available to Paidegao by law, Paidegao has the right to exercise one or more of the following rights or remedies:

- (i) to charge interest at a reasonable rate decided by Paidegao;
- (ii) to cancel the sale;
- (iii) to publicly or privately resell the property on terms that Paidegao considers fit;
- (iv) to hold the defaulting successful bidder liable for the total amount due and to commence legal proceedings for its recovery in addition to interest, legal fees and costs to the fullest extent permitted under applicable law;

Except as required by local law, any warranty of any kind whatsoever is excluded by this paragraph.

6. No Guarantee, Warranty or Representation

(a) Prior to the auction, Buyers should satisfy themselves with the condition of each lot and should exercise and rely on their own judgment as to the genuineness or authenticity of any lot. All goods are sold on 'as is' basis. Subject to the obligations accepted by Paidegao Auctioneer Limited ("Paidegao") under this Condition, neither the Seller, Paidegao, their respective staff nor agents are responsible for errors of description or for the genuineness or authenticity of any lot. Paidegao holds at all times the copyright in all images, illustrations and written material produced by or for Paidegao relating to a lot including the contents of this catalogue. Without Paidegao's prior written consent, the copyrighted materials shall not be used by the buyer, nor by anyone else. Paidegao and the seller make no representation or warranty that the buyer of a property will acquire any copyright or other reproduction rights in it.

8. SEVERABILITY

If any court finds any part of these Conditions of Sale is invalid, illegal or unenforceable, that part shall be discounted and the rest of the conditions shall remain valid to the fullest extent permitted by law.

9. DATA COLLECTION

In connection with the operation of our auction business, we will need to seek personal information from you or obtain information about you from third parties (eg. credit checks from banks). Such information will be processed and kept by us in confidence, but may be shared with our affiliates to assist us in providing you with a complete range of services, for customer analysis and to help us to tailor our services to buyer requirements. Some of your personal data may also need to be shared with third party service providers (eg. shipping or storage companies) for your benefit. By participating in our auction, you agree to all previously stated disclosure.

10. LAW AND JURISDICTION

The rights and obligations of the parties with respect to these Conditions of Sale, the conduct of the auction and any matters connected with any of the foregoing shall be governed and interpreted by the Hong Kong laws. By bidding at auction, whether present in person or by agent, by written bid, telephone or other means, the buyer accepts these Conditions and is submitted, for the benefit of Paidegao, to the exclusive jurisdiction of the Hong Kong courts.

拍賣規定

這裡列出的拍賣規定及重要通告及目錄實務解釋包含所有拍得高拍賣（國際）有限公司（「拍得高」）、賣家與買家所定的合約條款。這些條款可於拍賣時經張貼之通告或口頭宣佈修改。當競投者參與拍賣，他們同意受這些條款約束。

1. 拍得高作為拍賣代理

除另作聲明外，拍得高的角色為拍賣品賣方的代理。拍賣品的銷售合約適用於買賣雙方。

2. 拍賣前

(a) 拍賣品之檢驗

在拍賣會舉行前，準買家應親自檢驗他們有興趣購買之拍賣品。在要求下，拍賣行一般會給予準買家拍賣品狀況的報告。拍得高及賣方除有限保證外（請參閱以下第六段），均不會對拍賣品的性質作出保證。而拍賣品亦是以其拍賣時的現狀出售。

(b) 目錄及其他說明

本公司在關於拍賣品之目錄、或在物品狀況報告或其他地方內之所有口頭或書面陳述，均只屬意見之陳述，而不應當作為事實之陳述。此陳述並不構成本公司任何形式之任何陳述，保證或責任承擔。目錄或物品狀況報告中所提及之有關瑕疵或修復，只作為指引，而應由競投者或具備有關知識者親自檢查。未有此等資料的陳述，不代表拍賣品完全沒有瑕疵或修復。如已提述特定之瑕疵，並不代表拍賣品沒有其他瑕疵。拍賣品之估價，不應被依據為拍賣品成功拍賣之價格，或用作其他估價用途。除非如下文第6段所列，拍得高及賣家均不會對目錄或任何補充資料中的任何錯誤及遺漏負責。

(c) 買家之責任

除在下文第6段有限保證訂明外，所有拍賣品均以其「現況」拍賣，拍得高或賣家均不就此作出任何陳述或保證。買家有責任查明並了解有關拍賣品之狀況及目錄所提及之事項，並且確定自己對此感到滿意。

3. 拍賣之時

(a) 拒絕進入拍賣場地

拍得高有絕對之酌情決定權拒絕任何人士進入拍賣場地或參與拍賣，亦可拒絕接受任何競投。

(b) 競投之前作出登記

準買家在競投前，必須填妥及簽署登記表格，並提供身份證明。本公司可能要求準買家出示用作付款的銀行資料或其他財政證明。

(c) 競投者為委託人

在競投時，競投者是以個人承擔法律責任去繳付拍賣價，包括買家所支付的酬金及所有適用的稅項，以及其他所有適用的費用。假如代理人代第三方參與競投，他必須在競投前明確取得拍得高的書面同意。在此情況下，拍得高只會向委託人收取款項。

(d) 書面競投

為方便不能親身出席拍賣，或不能由代理人或通過電話拍賣的客戶，如拍得高在競投開始前收到書面競投，則會盡其合理努力代其競投。如拍得高就某一拍賣品收到多個競投價相等之書面競投，而在拍賣時此等競價為拍賣品最高之競投價，則該拍賣品會售予書面競投最先送抵本公司而被接納之人。除非在競投時有其他委託，此項書面競投的執行是本公司免費服務。拍得高不會因未能執行書面競投，或在當中出現之任何錯誤及遺漏負任何責任。

(e) 電話競投

如準買家於拍賣前與拍得高作好安排，可以電話參與競投。拍得高將盡合理努力聯絡準買家，但在任何情況下，如未能聯絡或在電話競投中有任何錯誤及遺漏，本公司均不負任何責任。

(f) 貨幣兌換顯示板

在某些拍賣會上，本公司會使用貨幣兌換顯示板，而該等顯示板在操作上可能出現錯誤。競投者宜跟隨拍賣場的實際競投。如競投者因依賴貨幣兌換顯示板而非拍賣場的實際競投，而蒙受損失，本公司概不負責。

(g) 視頻或數碼影像

在有些拍賣中，會有視頻或數碼屏幕，但其操作或會出現錯誤，而影像之

質素可能未能令人滿意，本公司均不就該等錯誤負任何責任。

拍得高保留對拍賣會進行錄像及紀錄拍賣過程之權利。拍得高會保密所得之個人資料。為了公司研究客戶群之目的，這些資料可能與我們的聯繫人仕及營銷夥伴分享共用。任何買家如不希望被攝於錄像，則可安排電話競投。如欲取得更詳細資料，請參閱上述3(e)部份。

(h) 底價

部份拍賣品設有底價。底價乃拍賣品的保密最低價，拍賣品不會以低於此價出售。此底價不會高於目錄中所示的最低估價。拍賣官可以代賣家以低於拍賣品的底價開始拍賣。拍賣官也可以連續競投方式或以回應其他競投者的投價而競投的方式，繼續代賣家競投到底價的金額。

不設底價的拍賣品，除已有競投，否則拍賣官有權自行斟酌定開價，通常會以拍賣品的售前估價下限的50%開始拍賣。若在此價格並無投標，拍賣官會自行斟酌將價格下降繼續拍賣，直至有客戶開始競投，然後再由該投標價向上繼續拍賣。在沒有更高叫價的情況下，不在場投標會以售前估價下限大約50%成交，但是若該投標價低於售前估價下限的50%，則以該投標價交易。

(i) 拍賣官之酌情決定權

拍賣官具有絕對及全權酌情決定權去拒絕接受任何競投，以其決定之方式進行拍賣，將任何拍賣品撤回或分開拍賣，將任何兩件或多件拍賣品合併拍賣。如遇有出錯或爭議，不論在拍賣之時或之後，拍賣官有權決定成功競投者，繼續拍賣，取消拍賣或將有爭議性的拍賣品重新拍賣。如在拍賣後有任何爭議，將會以本公司的拍賣記錄為依歸。

(j) 成功競投及風險的轉移

在拍賣官之酌情決定權下，出價最高且被拍賣官接受的競投者將為買家，而下槌則顯示最高競投價已被接受，亦表示賣家與買家之間的拍賣合約之訂立。拍賣品之風險及責任，不包括其所有權，在出售日起七個工作日期滿或在買家於期滿前提取該物品時，轉移到買家。

4. 拍賣之後

(a) 買家支付之酬金

買家同意在支付成交價外，還要支付拍得高酬金及任何適用之稅項及費用。酬金為每件拍賣品之落槌價之15%。

付款及所有權的轉移

於出售後，買家需立即向本公司提供其姓名及永久位址，如有需要，亦須提供付款銀行之詳情。買家須於拍賣日期後第七個工作日的下午四時半或之前悉數支付所有欠款（包括成交價、買家須支付之酬金以及任何適用之稅項）。即使買家希望將拍賣品出境，並需要或可能需要出口許可證，此一付款條款亦適用。縱使在拍得高已將拍賣品交給買家的情況下，買家仍未取得該拍賣品之所有權，直至買家就欠拍得高的所有款項悉數付清並為純淨資金為止。

(b) 領取已購拍賣品

拍得高有權保留已成功拍賣之拍賣品，直至買家就欠拍得高的所有款項悉數支付且為純淨資金，或直至買家已履行拍得高在獨有酌情決定權利下訂定之其他條款。符合上述條件的買家須於拍賣起三十五日內領取已購拍賣品，除非拍得高與買家另有約定。如買家未於上述指定期間內領取拍賣品，拍得高會安排儲存該拍賣品，並向買家以每件拍賣品每天收取港幣50元。

(c) 包裝、處理及運送

儘管拍得高在處理、包裝及運送已購拍賣品時盡合理努力小心妥當處理，本公司不會對就此而聘請的第三方之行為或遺漏負責。同樣地，拍得高可應要求而建議使用其他辦理商、包裝商或運送供應商時，也不會負責或承擔其行為或遺漏引致的任何責任。

(d) 出口許可證

買家應自行辦理任何相關出口或入口許可證。任何許可證申請之否決或延誤並不構成該出售之撤銷或延遲悉數付清拍賣品款項之理由。

在沒有拍得高書面同意的情况下，買方須於七天內付款。買方即使要申請出口許可證，也不應影響買方該責任及拍得高因買方遲還款項而行使收取利息或收取倉庫保管費之權利。如買家要求拍得高代其申請出口許可證，拍得高則有權就此服務收取費用。如買家需要額外支付申請出口許可證之款項，拍得高並無義務廢止拍賣或退還利息或退還買家已招致的其他支出。

(e) 不付款之補救辦法

如買家未有在上述第 4(a) 條的期限內繳付全款及有效清賬，除法律賦予拍得高之任何其他權利或補救辦法外，本公司有酌情決定的權力行使以下一項或多項權利或補救辦法：

- (i) 根據拍得高決定之合理利率收取利息；
- (ii) 取消該項拍賣品之交易；
- (iii) 根據拍得高認為適當的條款對拍賣品公開或向私人重新售賣；
- (iv) 不履行義務的買家須承擔尚欠之全部金額及因取回此金額而開始的法律訴訟程序及在適用法律中許可最大程度之內的利息及訴訟費用；
- (v) 代不履行責任的買家支付予賣家其應付的拍賣淨價金額；
- (vi) 將拍得高在任何其他交易中欠下買家之款項，用以抵銷買家未付之款項；
- (vii) 如買家因多項不同之交易而欠下拍得高數筆款項，將所付之款項用以清償某特定交易之欠款，而不論買家是否指示用以清償該筆款項；
- (viii) 在將來的任何拍賣中，拒絕買家或其代表作競投或於接受任何競投前向買家收取按金；
- (ix) 採取任何其他拍得高認為需要或適當之行動。

如本公司因上述第 (iii) 段重新售賣拍賣品，不履行義務的買家將負責償付原來尚欠拍得高的全數及再重售時的價格差額，及負責任何有關拍賣或因不履行責任時產生的費用、支出、損害賠償、律師費、佣金及酬金。如拍得高因上述 (v) 段支付賣家任何金額，買家則承認拍得高擁有賣家之所有權利，不管如何產生，可就此金額向買家提出追討。

(f) 未有領取已購拍賣品

如已購得之拍賣品未有在成功拍賣起三十五日內領取，則不論付款與否，拍得高有權在買方支付每件拍賣品每天港幣 50 元的情況下，安排儲存事宜。而只有在該買家付清所引致之搬運、貯存、處理、保險及任何其他費用，連同欠拍得高之所有其他款項之後，方可領取已購拍賣品。

5. 拍得高之法律責任

拍得高同意在下文第 6 條有限保證中所列出之情況下退還購買款項。除此之外，不論賣家、拍得高及其僱員或代理人對任何拍賣品就任何種類的口頭或書面陳述的正確，或任何其他說明之誤差或遺漏，或任何拍賣品之任何缺陷均不負任何責任。除在下文第 6 條訂立之外，賣家、拍得高及其僱員或代理人均無須就任何拍賣品有關描述、大小、質量、狀況、原創性、真實性、罕有程度、重要性、媒介、出處、可銷性、對某特定用途的適用性、展覽歷史、刊物或歷史的關聯等作出任何陳述、保證、擔保或承擔任何責任。除非當地法律有特別要求，任何種類之擔保，均不包含在本段之內。

6. 本行不作任何保證、擔保或陳述

(a) 在拍賣會前，買方應確保滿意拍賣品的狀況，並自行判斷拍賣品的真偽。所有物品均以「現狀」出售。除此買賣條款列明之責任外，拍得高拍賣有限公司（「拍得高」）、賣方和其各自的員工及經紀人，概不對任何拍賣物品的描述或真偽負責；賣方、拍得高和其各自的員工及經紀人均沒有對任何拍賣品發出任何保證條款，而任何明確或暗示性的條款或保證條款均已撤回。

(b) 假如買方證實投得的拍賣品是贗品，有關買賣可被取消，買方所付的所有費用（不包括期間的利息收入）可悉數退還給買方，但需符合下列條件：

- (i) 買方在拍賣會結束後十四個曆日內把拍賣品交還予拍得高，且拍賣物品的狀況和拍賣當天一樣；
- (ii) 拍得高同意有關拍賣品為贗品；
- (iii) 於有關拍賣會後，買方一直保留該拍賣品不受干預的所有權，且能夠並將會將拍賣品可完整轉售的所有權轉讓，且當中並不附帶任何留置權或其它負擔。
- (iv) 買方不得就因此而導致的直接或間接的損失索取任何賠償；
- (v) 獲得退還款項的權利不得轉讓，款項將退還給買方，即該拍賣品原有發票上的收票人；

(c) 在不背離其他拍賣條款的一般性原則下，買方請緊記拍得高和賣方均沒給予任何和鐘錶有關的拍賣品明確或暗示性的保證條款或陳述，拍得高和賣方一概不保證這些拍賣品的可銷性、真偽、屬性、出處、狀況、生產或製造年份，圖錄及網站上的任何描述均不能被視為保證條款或陳述。

7. 版權

由拍得高或為拍得高製作的與拍賣品相關的所有影像、說明及書面材料以及本目錄之所有內容之版權，無論何時均屬拍得高所有。未經拍得高事先書面同意，買家或任何人均不得使用受版權保護的材料。拍得高及賣家均沒有陳述或保證買方成功競投後即取得了該拍賣品之版權或其他複製的權利。

8. 可分割性

如本拍賣規定之任何部份遭任何法院認定為無效、不合法或不能執行，則該部份可不予理會，而本拍賣規定之其他部份在法律許可之最大範圍內須繼續有效。

9. 資料搜集

就經 本公司的拍賣業務方面，本公司需要向閣下搜集個人資料或向第三方索取有關閣下的資料（如向銀行索取信用審核）。這些資料會由本公司在機密情況下處理及保存，唯有關資料有可能提供給本公司之聯繫人仕，以協助本公司為閣下提供完善的服務，進行客戶分析，及以便提供符合買家要求的服務。為了閣下的權益，本公司亦可能需要向第三方服務供應商（例如船運公司或存倉公司）提供閣下的部分個人資料。閣下參與本公司的拍賣，即表示閣下同意上文所述。

10. 法律及司法管轄權

各方就有關本拍賣規定，拍賣的行為及任何與上述條文的事項的權利及義務，均受香港法律管限並解釋。在拍賣競投時，無論是親自出席或由代理人出席競投，或以書面、電話或其他方法競投，買家則被視為接受本拍賣規定，及為拍得高之利益而言，服從香港法院之排他性司法管轄權。
